- 2. That WEG has my consent to order an autopsy or test (at WEG's expense) for any horse that is euthanized or otherwise dies for any reason while on WEG's premises, and to collect any samples (e.g. blood samples) that may be required in this regard. Any such incident must be reported to the stall office immediately.
- 3. That I am presently in possession of a good and valid Stable Area Access Sticker for the current year and I have signed and agreed to all the terms and conditions connected with the possession of a Stable Area Access Sticker.
- 4. That I have received and executed an Application for Access Rights (Form A) in favour of WEG and agree to be bound thereby.
- 5. That my use of any stalls as may be granted by WEG under this Application is in consideration of my participation in the WEG Racing Program.
- 6. That determination by WEG in its sole discretion that I am not making my best efforts to participate and/or to cause any applicable owner to participate in the WEG Racing Program, or am not in compliance with the WEG Rules and Regulations, including without limitation the Code of Conduct, may result in loss of use of some or all of the stalls.
- 7. That this Contract is made with and shall endure to the benefit of WEG.
